

SCHEDULE 1

A. SIGNIFICANT ACCOUNTING POLICIES

1. **Accounting Convention** - The Financial Statements are drawn up keeping in mind the historical cost and going concern concept and in accordance with generally accepted accounting principles and practices prevailing in India.
2. **Revenue Recognition** - Income and Expenditure is accounted on Accrual Basis. Life Membership Fees received from its Members is treated as Income of the Society and not capitalised to the Life Membership Fund Account.

B. NOTES TO ACCOUNTS

- 1 The Statutory Audit of the Financial Statements of the Society for the year 2017-18 was not conducted within the period of time stipulated under The Societies Registration Act, 1860.
- 2 Comparative financial information (i.e. the amounts and other disclosures for the preceding year presented above), is included as an integral part of the current year's Financial Statements, and is to be read in relation to the amounts and other disclosures relating to the current year. Figures of the previous year have been regrouped / reclassified wherever necessary to correspond to figures of the current year.
- 3 The Society has neither paid Income Tax on net income earned by it, nor filed the Income Tax Return as per the requirement of section 139(1) of the Income Tax Act, 1961.


